In the case of Cyprus, my country strongly supports the territorial integrity, independence and sovereignty of the Republic of Cyprus as well as the resolutions of the United Nations Security Council as the basis for reaching a comprehensive settlement fully in line with International Law.

Your Excellency,

I take this opportunity to convey to you the warmest greetings from President Andrés Manuel López Obrador and I personally look forward to working with your Government to enhance and diversify our relations for the mutual benefit of Mexico and Cyprus.

Address by the Ambassador of Chile, Mrs Marisol Cecilia Amparo Pérez Carranza, presenting her credentials to the PoR of the Republic of Cyprus, on June 9, 2023

Your Excellency,

I have the honour to present the Letters of Credence by which the President of the Republic of Chile, Mr Gabriel Boric, has accredited me as Ambassador Extraordinary and Plenipotentiary of the Republic of Chile.

Cyprus and Chile share the most basic values, such as the promotion of democracy, the respect of human rights, the reinforcement of civil rights, and equality for all their people. Also, we share similar challenges, such as overcoming poverty, transparency, economic stability, high quality education and gender equality.

Europe has always constituted a relevant area for our foreign policy. In 2002, my government signed an Association Agreement with the European Union, which laid out the foundations for a closer relationship. The joining of Cyprus to the European Union in 2004 established the bridge for a broader liaison. More now, that the agreement is being upgraded and is now under legal revision. This new agreement will most certainly boost the political dialogue, the cooperation, and the economic and our trade relations, with a more diversified agenda that includes science, technology, research and innovation for the development of our international competitiveness, with the participation of Small and Medium Size Companies, universities and scientific agencies. In this context, we believe that agricultural development, renewable energies, collaboration in new technologies under start-up programs, geology — especially copper and lithium — as well as academic cooperation, are areas in which there is an important potential for fruitful cooperation, that I look forward to work closely with your Government.

Our common views have created a fruitful ground for multilateral assistance, cooperation and mutual support for candidatures in several international organizations. Within the framework of this collaboration, Mr President, Cyprus supported the Chilean candidate to the International Court of the Sea for the period 2020-2029, a woman whose election came

in accordance with one of Chile's most important foreign policy pillars, which is the strict respect for international law, the inviolability of treaties, the judicial and peaceful resolution of controversies, non-interference in the internal affairs of other States and the search for peace and international security. This policy, obviously, has been especially significant in the field of maritime delimitation and the extension of continental shelves, where the Republics of Cyprus and Chile share the same views.

Between our nations, a clear manifestation of friendship throughout the years has been our participation in the United Nations Peacekeeping Force in Cyprus (UNFICYP). Since year 2003 we have had a group of military observers, a policy that is aimed at alleviating the consequences of the territorial division, for which we hope to find a comprehensive and peaceful settlement. We have a strong commitment with Peace and Security, and we believe in the importance of promoting and reinforcing multilateral institutions, while supporting democratic and human rights principles, as well as equity at the international level.

Finally, I would like to stress two important policies that the Government of Chile is actively pursuing. One is the so-called Turquoise Foreign Policy, which combines the priorities of our BLUE sea with the challenges presented by the GREEN environmental field, which is aimed at promoting concrete actions to develop solutions in harmony with nature in order to ensure the conservation of biodiversity at a global level. And the second is the so called Feminist Foreign Policy, which aims to enhance the role of women at the highest levels of policy making. We, WOMEN, can enrich the debate at every public space where we have the chance to participate. Thus, this policy's objective is to allow women to reach the highest level of policy decision-making, a traditionally male-dominated field, especially in foreign policy. In this sense, we would like to see that our bilateral relation moves upon this path.

Your Excellency, I am confident that considering the international backgrounds of Cyprus and Chile, we are in good condition to face together the many challenges that lie before us, and grasp relevant opportunities in the bilateral aspect that will help us to further develop new areas of cooperation, cultural exchange and business between our countries.

Address by the Ambassador of El Salvador, Mr Efrén Arnoldo Bernal Chévez, presenting his credentials to the PoR of the Republic of Cyprus, on June 9, 2023

Your Excellency, Mr President Christodoulides,

It is my privilege to be the bearer of friendly greetings from the President of the Republic of El Salvador, His Excellency Nayib Bukele, who has entrusted me with the honour of presenting to Your Excellency the Letters of Credence accrediting me as Ambassador Extraordinary and Plenipotentiary of El Salvador to the Honourable Republic of Cyprus.

This is an opportune occasion to express the high appreciation of the Republic of El Salvador for the friendly ties that have united our countries and our peoples for 24 years, when our governments took the wise decision to establish diplomatic relations. Mr President, please accept our warmest congratulations on the recent democratic election process that culminated in your election by the Cypriot people. I also wish to express my readiness to work closely with you, Excellency, in further strengthening friendly relations and identifying new areas of mutual collaboration.

President Bukele is convinced that the development of nations is enhanced through the virtuous path of cooperation, both bilaterally and multilaterally, and through the exercise of the noble principles of international law, such as full respect for the sovereign equality of all peoples.

In this spirit, my country is open to work closely with the Honourable Republic of Cyprus in favour of our common interests and the prosperity of our peoples, through the strengthening of diplomatic, economic, commercial, tourism and cultural ties that unite us, in addition to joint collaboration in different multilateral spaces of priority for our governments. We are particularly interested in the organisation of the first meeting of political consultations and the development of trade and investment between our nations, taking advantage of the Association Agreement between Central America and the European Union.

El Salvador has entered a new stage in its history, marked by the promotion of actions aimed at settling the historical debts that previous governments had with our people. In this

way, the structural factors that have hindered the well-being and full enjoyment of rights of Salvadorans are finally being addressed.

Thanks to the efforts led by President Bukele, and four years of his administration, the progress the country has made is evident. The process of insecurity in which Salvadoran society was living has been reversed, changing from being the most violent country in the world to the safest in Latin America, thus guaranteeing the full enjoyment of rights and freedoms for Salvadoran families; important results are being achieved in terms of sustainable development and social inclusion, as well as in the promotion of peace, which has led to a high level of approval by the Salvadoran population.

This is thanks to the institutional renewal process that El Salvador is undergoing, as well as the implementation of public policies focused on our people, which encompass aspects such as the reduction of inequality, early childhood and youth development, food security and autonomy, investment in strategic projects that support development, among others.

In 2020, when the whole of humanity was faced with the Covid-19 pandemic, El Salvador adopted containment, treatment, vaccination and general prevention measures, as well as fiscal measures to reduce the economic impact on households and businesses. This strategy has earned El Salvador the recognition of the World Health Organisation, making it a benchmark for countries in the region.

Likewise, children are provided with computer tools to facilitate their education, the percentage of gross domestic product allocated to education and health has increased, and greater employment opportunities are created, with a commitment to the development of micro, small and medium-size enterprises and the integration of production chains. At the same time, there has been an increase in the development of projects to attract tourism – where surfing deserves special mention – as well as the modernisation of road infrastructures and mass passenger transport.

In the economic sphere, efforts have been made to increase productivity, reduce remittance transfer costs and seek alternative sources of investment. In this context, Bitcoin has been introduced as legal tender, which has reduced the cost of remittances from our compatriots abroad, leading to an increase of seven billion dollars in remittances, demonstrating the

benefits of democratising our monetary policy in order to enhance the economic and social development of the people.

The Government of El Salvador renews its kind invitation to friendly countries, including the Republic of Cyprus, to join and support the process of national transformation, with a view to progressively advance towards the construction of a great and prosperous nation, offering better opportunities for development.

El Salvador reiterates its commitment to the maintenance of peace, to respect the international law and the purposes and principles enshrined in the Charter of the United Nations, while advocating dialogue and negotiation as tools for the peaceful settlement of disputes between States. In this regard, El Salvador trusts that the parties involved will be able to find a negotiated solution to the conflict that is compatible with their national interests and with the legal commitments adopted on the matter, on the basis of goodwill and mutual respect, in the interests of maintaining regional security and stability.

Your Excellency, Mr President, before concluding my remarks, allow me to express to you, on behalf of the Salvadoran people and President Nayib Bukele, my most sincere wishes for peace, well-being and prosperity for the Republic of Cyprus and its people. We trust that our relations will continue to strengthen over time and that our high aspirations for development will serve as a catalyst for joint efforts to produce mutually beneficial results.

Address by the Ambassador of Modlova, Mr Andrei Popov, presenting his credentials to the PoR of the Republic of Cyprus, on June 9, 2023

Your Excellency, Mr President,

It is my distinct honor and privilege to present to you the Letters of Credence accrediting me as Ambassador Extraordinary and Plenipotentiary of the Republic of Moldova to the Republic of Cyprus. I would like to take this opportunity, to convey to you on behalf of the President of the Republic of Moldova Maia Sandu and the people of the Republic of Moldova the heartfelt greetings, along with the sincere hope that the friendly relations between our countries will further develop and expand to the benefit of both peoples.

It is particularly symbolic that today's ceremony is taking place just a week after your Excellency visited the Republic of Moldova to participate in the Second Summit of the European Political Community and shortly after your first meeting with President Sandu in Reykjavik in mid-May. We especially value the principled position that you reiterated on these occasions regarding Cyprus's respect of the territorial integrity, sovereignty and independence of the Republic of Moldova, as well as your country's full support towards Moldova's European integration and willingness to further assist Moldova on this path.

Your Excellency,

Moldova is passing through a decisive juncture in its history with both tremendous challenges and great opportunities.

For fifteen months a brutal war of aggression is waged by Russia against our neighbor Ukraine. While nothing compares to the tragedy and sufferings of Ukraine and its people, Moldova is arguably the second most exposed and most affected country by this war. Without the EU or NATO protection and with Russian troops still illegally stationing in the separatist Transnistrian region of Moldova, when the war broke out and Russian tanks were advancing towards our borders, we felt directly threatened and vulnerable. However, now-particularly after Ukraine succeeded to liberate Kherson and as long as it keeps the front line far from our borders - we no longer feel threatened militarily. Nevertheless, Moldova continues to cope with multiple negative effects of this war in the security, energy, trade,

economy and social fields. We also face hybrid threats, cyber-attacks, fake bomb alerts, propaganda, disinformation campaigns and attempts to destabilize the political situation by fugitive Moldovan oligarchs working together with Russia.

Despite all these challenges, we have managed to keep the situation stable and under control. We have also succeeded in achieving substantial progress in the area of justice reform, fighting corruption, bringing down inflation (from 34% last year to 16%), strengthening institutions, improving business climate and fostering societal and economic resilience. Apart from this, we have managed to overcome our dependence on the Russian energy, by finding alternative sources, strengthening our energy infrastructure, and promoting energy efficiency programs. Our paramount goal is to succeed in building a modern and competitive country where institutions and justice work in the interests of citizens and not in the interest of corrupt groups.

We see the full integration into the European Union as the only chance to survive as democracy and to restore the people's trust in our country's future. Last June, Moldova obtained, together with Ukraine, the EU candidate status. Our next goal is to open EU accession negotiations by the end of 2023, based on accelerating reforms and full implementation of EU recommendations. The Republic of Cyprus has experienced firsthand the positive transformational impact of the EU accession and membership and is a strong supporter of the EU enlargement process. We value very much this position and rely on your continues support to our European path.

Mr President,

For more than three decades, the unsolved Transnistrian conflict has been hampering my country's development and undermining regional security. As there are no ethnic or religious contradictions between the people on the two banks of the Nistru river, this conflict would have been long ago solved if it was not for the adverse external influences, namely the Russia's attempts to instrumentalize this frozen conflict to bring Moldova in its "sphere of influence".

Since 2005, the negotiations have been taking place in the "5+2" format, that includes OSCE, Russia and Ukraine as mediators, and EU and US as observers. However, the "5+2" has not convened since 2019 and it is hard to imagine how negotiations in this format

can resume as long as Russia is waging its war of aggression against Ukraine. Therefore, today the main platform for interaction with Tiraspol is in the "1+1" format of chief negotiators, backed by a dozen sectorial working groups. We are also engaged in a pragmatic dialogue with the Transnistrian de facto administration in order to solve current problems and make sure this conflict doesn't escalate. In parallel, we maintain a very favorable regime of trade for Transnistrian businesses, that over the years has led to a complete reorientation of the region's exports to the EU market. We also encourage people-to-people contacts, confidence building initiatives, joint projects and promote freedom of movement across the internal administrative line.

We are firmly committed to exclusively peaceful means for finding a comprehensive and sustainable solution to the Transnistrian conflict, based on the sovereignty and territorial integrity of the Republic of Moldova within its internationally recognized borders and without undermining the European perspective of the Republic of Moldova. The chances of achieving such a solution will largely depend on when, where and how the war will end. Here, it is necessary to emphasize the importance of full withdrawal of Russian troops and ammunitions illegally deployed on our territory, in accordance with international law and the OSCE commitments.

I take advantage of this opportunity to reiterate the principled and firm position of the Republic of Moldova in support of the territorial integrity, sovereignty and independence of the Republic of Cyprus, as well as of the comprehensive settlement of the Cyprus Problem on the basis of International Law and in line with the UN Charter and the relevant United Nations Security Council resolutions.

Your Excellency,

As Ambassador of the Republic of Moldova to the Republic of Cyprus, and with Your Excellency's kind support, I look forward to contributing during my mandate to further strengthening and diversifying our friendly relations and cooperation, both at bilateral and multilateral level, advancing economic cooperation, trade, investments, cultural and educational programs, cooperation in consular affairs, in the field of labor and social security. As President Sandu mentioned to you, we also express our gratitude for the good cooperation between our competent institutions in the field of prevention and combating money laundering and recuperation of the illegally acquired properties.

For me it is a great honor to be appointed Ambassador to your country. I would like to assure You that I will make every effort to advance cooperation and friendly relations between the Republic of Moldova and the Republic of Cyprus, as well as to become a reliable partner and a true friend of Cyprus and of its people.

Address by the High Commissioner of New Zealand, Mrs Jacqueline Anne Frizelle, presenting her credentials to the PoR of the Republic of Cyprus, on June 9, 2023

New Zealand and the EU have recently concluded negotiations of a Free Trade Agreement, which will deliver tangible benefits for all involved, including Cyprus. I want to extend my government's thanks for Cyprus' ongoing support in this area.

There have also been recent opportunities for our countries to support each other's candidatures for various international positions and organisations. My government thanks Cyprus for the support it has and conveys its pleasure at being able to support Cyprus' candidatures.

Strengthening these connections will be my priority during my tenure as High Commissioner to the Republic of Cyprus. Once the FTA is ratified, there will be opportunities to grow the economic connections between our two countries. I hope we can also work together to strengthen the rules-based order and ensure the voices of small states are heard particularly in meeting the key challenges of our time; climate change and threats to international security.

I take this opportunity to renew to you the assurance of the Governor-General's continuing interest in and best wishes for the welfare and prosperity of the Republic of Cyprus. I convey warm greetings from the Government and people of New Zealand. And I look forward with excitement to working in order to advance the friendly bilateral relations between our two countries.

Your excellency, Mr President,

I have the honour to present to you the Letter that accredits me as extraorinary and plenipotentiary Ambassador of the Republic of Peru to the Republic of Cyprus, as well as the letter of recall of my predecessor.

Mr President, I bring greetings from the Government and the people of Peru, especially, the great satisfaction for the traditional ties of friendship, fraternity and cooperation that have characterized the relations between our countries and the sincere wishes of success in your mandate that initiates.

Our shared values and principles for the promotion and protection of democracy, human rights, rule of law and, in particular, international law, have been reflected in the very fluid and positive coordinations and shared stances in multilateral fora, in particular in the case of those refering to essential international law principals, such as sovereignty, independence and territorial integrity of all states, values you have embodied and excelled during your meaningful career as diplomat, politician and head of the chipriot diplomacy, as we can all testify.

In that sense, Mr President, regarding the Cyprus issue, I would like to stress Peru's unequivocal respect for the commitments enshrined in the United Nations Charter, as has been expressed in our permanent support for the secretary general's efforts to facilitate a return to formal negotiations, in order to achieve an enduring, comprehensive and fair solution, based on a bicommunal and bizonal federation, according to the resolutions of the United Nations Security Council.

In the same line, Peru firmly condems the russian invasion to Ukraine, and urgently demands positive outcomes by peaceful means provided for in international law.

Mr President, our countries share a great cultural heritage, which allow us to cooperate in the programming of joint works for the promotion of our ancestry and traditions, through the establishment of coordination channels between our authorities in charge of the protection and preservation of our historical, archeological and cultural legacy.

We are convinced of the need to promote and improve our bilateral trade with a win-win approach. We will facilitate the contact and organize video-conferences between our business associations, so that they can directly identify trade and investment business opportunities.

This, also, includes the great possibilities of promoting bilateral tourism, an area in which we will deploy enhanced efforts, not only for the importance it has for the economy of our countries, but also because of the benefits in mutual knowledge of our rich cultures amongst our people.
